23 Plaintiff JONATHAN ARTHURS ("Plaintiff" and/or "Arthurs"), and Defendant
24 CITY OF BAKERSFIELD "Defendant"), by and through their undersigned counsel, hereby
25 stipulate as follows:

26 1. Counsel for Defendant, John R. Szewczyk, has encountered a conflict in dates
27 with respect to the currently scheduled Pre-Trial Conference now set for January 30, 2017.
28 Counsel will be out of state for the week leading up to, and actually travelling on the currently
scheduled date of January 30, 2017. This effectively leaves Counsel for Defendant unable to

1 proceed with the currently set Pre-Trial Conference on January 30th.

2 2. In view of the unavailability of Defense Counsel, and after discussion with
3 Plaintiff's Counsel, all Counsel have agreed to a continuance with regard to the pending Pre-

9 2017.
