On September 12, 2016, Plaintiff filed a notice of settlement. Based upon the notice of 18 settlement, all pending dates and matters in this action were vacated and the parties were 19 20 required to file dispositional documents on or before October 28, 2016. When the parties failed to file dispositional documents, an order issued requiring the parties to show cause why this 21 action should not be dismissed. On December 11, 2016, Plaintiff filed a response stating that 22 after the parties had agreed to settle this action, the settlement agreement was sent to Mr. Warda 23 and no response was received. Plaintiff's counsel has not received the settlement documents 24 despite extensive attempts to communicate with Mr. Warda. 25

On December 32, 2016, Plaintiff filed a request to withdraw the notice of settlement based upon the failure of Defendants to pursue the settlement agreement. On January 4, 2017, an order issued granting the request to withdraw the notice of settlement and setting a scheduling conference in this action for January 17, 2017. Defendant's counsel did not appear for the
January 17, 2017 scheduling conference.

Local Rule 110 provides that "[f]ailure of counsel or of a party to comply with these Rules or with any order of the Court may be grounds for imposition by the Court of any and all sanctions . . . within the inherent power of the Court." The Court has the inherent power to control its docket and may, in the exercise of that power, impose sanctions where appropriate, including dismissal of the action. <u>Bautista v. Los Angeles County</u>, 216 F.3d 837, 841 (9th Cir. 2000).
