**ORDER FOR DEFENDANT TO FILE STATUS
REPORT WITHIN 30 DAYS**

19 Plaintiff Brian C. Applegate ("Plaintiff") is a prisoner in the custody of the California
20 Department of Corrections and Rehabilitation. Plaintiff is proceeding pro se and in forma
21 pauperis in this civil rights action pursuant to 42 U.S.C. § 1983. The action is proceeding on
22 Plaintiff's Eighth Amendment and state law claims against Defendant Christian Trausch.

23 On March 29, 2016, the Court granted Defendant's motion to stay the proceedings
24 pending resolution of Plaintiff's writ of mandate in the Sacramento County Superior Court. The
25 two inmate appeals that Plaintiff contends exhausted the issues herein were the subject of the
26 petition, and the Court granted the stay because the outcome of the petition would impact the
27 exhaustion analysis in this action. In granting the stay, the Court ordered Defendant to file a
28 status report within ten days of the state court's ruling on Plaintiff's petition.

1 On April 7, 2016, Plaintiff submitted a filing indicating that he *may* file a notice of
2 voluntarily dismissal if the state court determined that administrative remedies remained. An
3 actual request to dismiss has not been filed.

4 On July 21, 2016, Defendant filed a status report as directed by this Court. According
5 to the report, the state court denied the petition on July 11, 2016, finding that Plaintiff had not
6 demonstrated that he submitted the appeals and that staff had received them. Defendant
7 requested that the stay remain until the state court decision is final. On July 25, 2016, the Court
8 issued an order continuing the stay of the action.

9 On September 15, 2016, Plaintiff submitted a status report indicating that he was
10 awaiting the appeal record from the Sacramento Superior Court, after which time he expected
11 to pursue a mandamus action at the court of appeals. Plaintiff requested that the stay remain in
12 place.

13 The Court now requests a status report from Defendant. Accordingly, **IT IS HEREBY**
14 **ORDERED** that within thirty (30) days of the date of service of this order, Defendant SHALL
15 file a status report informing the Court of the current status of this case.
