The matter was referred to a United States Magistrate Judge pursuant to 28 U.S.C. § $636(b)(1)(B)$ and Local Rule 302. On May 25, 2017, the assigned magistrate judge issued finding and recommendations, recommending that this court deny defendants' request to consolidate this action with <i>Gonzales v</i> . <i>Garcia et al.</i> , No. 1:16-cv-01813-EPG (E.D. Cal. filed Oct. 12, 2016). (Doc. No. 42.) The findings and recommendations were served on the parties and contained notice that objections thereto were to be filed within twenty-one days. ( <i>Id.</i> ) No objections have been filed. <sup>1</sup> $1 \text{ On May 26, 2017, plaintiff filed an opposition to defendants' request to consolidate, whichconcurs with the magistrate judge's findings and recommendations.
