18 Brian Caputo ("Plaintiff") is a prisoner¹ proceeding *pro se* and *in forma pauperis* in this
19 this civil rights action filed pursuant to 42 U.S.C. § 1983.

20 On November 15, 2018, Plaintiff filed a letter to the Court. (ECF No. 133). Plaintiff
21 apologizes for missing the conference that was scheduled for November 7, 2018, explains that
22 it was not his fault that he missed the conference, and requests that the conference be
23 rescheduled.

24 The Court finds good cause to reschedule the conference. Although the Court has ruled
25 on certain motions that were pending before the last conference, the Court will be prepared to
26 address any outstanding issues and the status of the case.

28 ¹ Plaintiff was detained at Kern County Jail at the time of the incidents alleged in the complaint. He is
now incarcerated at USP Yazoo City.

1 Accordingly, IT IS ORDERED THAT:

- 2 1. A telephonic status conference is set for December 19, 2018, at 1:30 p.m.
- 3 2. To appear telephonically, each party is to use the following dial-in number and
4 passcode: 1-888-251-2909; passcode 1024453. Plaintiff shall make arrangements
5 with staff at his or her institution of confinement for his or her attendance at the
6 conference. Plaintiff's institution of confinement shall make Plaintiff available for
7 the conference at the date and time indicated above.

- 9 a. Warden Martin, USP Yazoo City, U.S. Penitentiary, P.O. Box 5666, Yazoo
10 City, MS 39194; and
