20 The parties herein, by and through counsel, stipulate to modify the discovery schedule  
21 as follows:

- 22 1. Due to Plaintiff's confinement and difficulties communicating through the prison mail  
23 system regarding responses to Defendants' discovery, Plaintiff has had to ask  
24 Defendants for two extensions to the deadline for verified responses. As of this date,  
25 counsel for Plaintiff is still waiting for verifications from Plaintiff.
