ORDER GRANTING PLAINTIFF'S
MOTION FOR ORDER APPROVING
SETTLEMENT OF MINOR
PLAINTIFF'S CLAIMS



23 Now before the Court is Plaintiff Maria Jimenez's Motion for Order Approving
24 Settlement of Minor Plaintiff A.J.J.'s Claims. Having reviewed Plaintiff's Motion, the Court
25 finds that proposed settlement is in A.J.J.'s best interest and is fair and reasonable in light
26 of the facts of the case. Accordingly, Plaintiff Maria Jimenez's Motion for Order Approving
27

1 Settlement of Minor Plaintiff A.J.J's claims is hereby GRANTED. The Court hereby
2 ORDERS as follows:

- 3 a. GRANTS the minors compromise approving settlement between the parties as
4 set forth herein;
- 5 b. ORDERS the Defendants to issue payment to Plaintiffs' counsel for the full
6 amount of the \$50,000 settlement within 30 days of the Court's Order approving
7 the minors compromises as specified in the parties' settlement agreement;
- 8 c. ORDERS a distribution of \$18,737.25 from the settlement funds to plaintiffs'
9 counsel, Needham Kepner & Fish, LLP, for reimbursement of costs incurred in
10 the litigation of this matter;
- 11 d. ORDERS that the remaining settlement proceeds of \$31,262.75, be distributed
12 in equal parts to plaintiffs Luis Andres Jimenez and Jose Luis Jimenez, Jr. This
13 settling minor will not receive any portion of this settlement but will receive a
14 waiver of fees and costs in exchange for a dismissal with prejudice.
- 15 e. Each party will bear its own costs, fees, and expenses.

16 IT IS SO ORDERED.
