16	2017, the Court issued an order directing Plaintiff to complete and submit service documents for	
17	any defendants listed in his 3AC who were n	ot previously served with process in this action.
18	(ECF No. 76.) The Court instructed Plaintiff	to provide information for service of process on
19	form USM-285, sufficient copies of the Com	plaint for service, and a notice of submission. Id.
20	Plaintiff has filed the requested papers. Acco	ordingly, IT IS HEREBY ORDERED:
21	1. The Clerk of the Court is DIR	ECTED to forward the following documents to the
22	United States Marshal Service	e:
23	a. One completed and iss	sued summons for each defendant to be served;

25	c. One copy of the Third	Amended Complaint filed on July 24, 2017 for each

3	e. One copy of the court's consent form for each defendant to be served.	
4	2. Within ten days from the date of this Order, the United States Marshal Service is	
5	DIRECTED to notify the following defendants of the commencement of this	
6	action and to request a waiver of service in accordance with the provisions of	
7	Federal Rule of Civil Procedure 4(d) and 28 U.S.C. § 566(c):

1	4. The United States Marshal Service shall file returned waivers of service as well as
2	any requests for waivers of service that are returned as undelivered as soon as they
3	are received;
4	5. If a waiver of service is not returned by a defendant within sixty days of the date of
5	mailing the request for waiver, the United States Marshal Service shall:
6	a. Personally serve process and a copy of this Order on the defendant
7	pursuant to Federal Rule of Civil Procedure 4(d) and 28 U.S.C. § 566(c);
8	b. Within ten days after personal service is effected, the United States
9	Marshal Service shall file the return of service for the defendant, along
10	with evidence of any attempts to secure a waiver of service of process and
11	of the costs subsequently incurred in effecting service on said defendant.
12	Said costs shall be enumerated on the USM-285 form and shall include the
13	costs incurred by the Marshal's office for photocopying additional copies
14	of the summons and Complaint and for preparing new USM-285 forms, if
15	required. Costs of service will be taxed against the personally served
16	defendant in accordance with the provisions of Federal Rule of Civil
17	Procedure $4(d)(2)$.
18	6. In the event that defendants make an appearance in this action by filing an answer,
19	dispositive motion, or other pleading, the United States Marshals Service need not
20	personally serve those defendants; and,
21	7. In the event that defendants either waive service or are personally served,
22	defendants are required to reply to the Complaint.
23
