1 On April 5, 2023, a status conference was held via Zoom video and telephonic conference. 2 As discussed on the record, the Court and the parties agreed to continue the trial date, which will 3 be confirmed by separate order. 4 In addition, on March 22, 2023, the Court issued writs of habeas corpus ad testificandum 5 directing the production of Plaintiff Reginald Ray York, inmate, CDCR #J-40227, and Plaintiff's 6 witness Michael Washington, inmate, CDCR #V-39680, for the April 25, 2023, trial date.
