13 **ORDER**

14 Good cause appearing, the Court **ORDERS** the case schedule amended as follows:

- 15 1. The parties **SHALL** complete all discovery related to experts no later than
16 **February 22, 2017**;
- 17 2. Non-dispositive motions **SHALL** be filed no later than **February 22, 2017** and
18 heard no later than **March 22, 2017**;
- 19 3. Dispositive motions¹ **SHALL** be filed no later than **March 7, 2017** and heard no
20 later than **April 4, 2017**.

21 **No other amendments to the case schedule are authorized and the Court is not**
22 **inclined to consider any further amendments to the case schedule.**
