**STIPULATION TO CONTINUE

17 WHEREAS, the parties in the above-captioned action are exploring a full and  
18 complete settlement of this matter, and are cautiously optimistic that such a settlement can be  
19 reached without the need for responsive pleadings to be filed or the holding of a scheduling  
20 conference.

21 WHEREAS, the parties wish to avoid the unnecessary expenditure of attorneys'  
22 fees and use of judicial resources while they exhaust their settlement efforts.

23 WHEREAS, the parties have not requested any prior extensions of time in this  
24 action.

25 THEREFORE, IT IS HEREBY STIPULATED by and between Plaintiff  
26 HENDRIK BLOCK ("Plaintiff") and Defendants TERRY O. HOBAN and PATTI I. HOBAN  
27 ("Defendants"), by and through their respective counsel, that due to the ongoing settlement  
28 negotiations, the Initial Scheduling Conference currently set for April 7, 2016 be continued to a

1 date and time at the Court's convenience on or after June 1, 2016, subject to Court approval.

2 IT IS FURTHER STIPULATED by and between Plaintiff and Defendants, by and  
3 through their respective counsel, that the deadline for Defendants to file a responsive pleading,  
4 currently set for March 14, 2016, be continued to May 13, 2016, subject to Court approval,  
5 pursuant to Rule 6 of the Federal Rules of Civil Procedure and Local Rule 144.
