("Defendants") filed their 25 Answer on March 14, 2016; 26 WHEREAS, a former employee of Defendant Pier 1 Imports (U.S.), Inc. wishes to serve as 27 a second class representative in this matter; 28

1	WHEREAS, Plaintiff also wishes to add two additional causes of action that derive from the
2	core factual allegations in this matter; namely, Defendant Pier 1 Imports (U.S.), Inc.'s "Call-In," or
3	"Flex Shift" scheduling policy;
4	WHEREAS, because Defendants have filed an answer in this matter, Plaintiff may no
5	longer amend her complaint as a matter of right; and
6	WHEREAS, the parties agree that placing all potential claims relating to Defendant Pier 1
7	Imports (U.S.), Inc.'s "Call-In" or "Flex Shift" scheduling policy at issue at this time would result
8	in the most efficient use of the Court's and parties' resources, and would maintain judicial
9	efficiency.
10	THEREFORE, the parties, through their respective counsel of record, stipulate that:
11	(a) Plaintiff will file the First Amended Complaint, attached hereto as Exhibit A, within
12	seven (7) days of an order granting this Stipulation; and
13	(b) Defendants will have twenty-eight (28) days from the date Plaintiff files her First
14	Amended Complaint to file their responsive pleading.
