28	IT IS HEREBY STIPULATED by and between the parties, through their undersigned	
		AND PAYMENT OF ATTORNEYS FEES AND EXPENSES SUANT TO EAJA

attorneys, subject to the approval of the Court, that Jimmy Lee Miskell (Plaintiff) be awarded
attorney fees and expenses under the Equal Access to Justice Act (EAJA), 28 U.S.C. §2412 (d), in
the amount of four thousand seven hundred thirty-four dollars and thirty-nine cents (\$4,734.39)
and expenses in the amount of eight dollars and ninety-four cents (\$8.94), for a total of four
thousand seven hundred thirty-four dollars and thirty-nine cents (\$4,734.39). This represents
compensation for legal services rendered on behalf of Plaintiff by counsel in connection with this
civil action, in accordance with 28 U.S.C. §2412 (d).

After the Court issues an Order for EAJA fees to Plaintiff, the government will consider
the matter of Plaintiff's assignment of EAJA fees to Plaintiff's attorney. Pursuant to *Astrue v*. *Ratliff*, 560 U.S. 586, 598 (2010), the ability to honor the assignment will depend on whether the
attorney fees are subject to any offset allowed under the United States Department of the
Treasury's Offset Program. After the Order for EAJA fees is entered, the government will
determine whether they are subject to any offset.

Fees shall be made payable to Plaintiff, but if the Department of the Treasury determines
that Plaintiff does not owe a federal debt subject to offset, then the government shall cause the
payment of fees approved to be made payable to Melissa Newel or Newel Law (collectively
"Plaintiff's counsel"), pursuant to the assignment executed by Plaintiff. Any payments made shall
be delivered to Plaintiff's counsel.

This stipulation constitutes a compromise settlement of Plaintiff's request for EAJA
attorney fees and does not constitute an admission of liability on the part of Defendant under
EAJA. Payment of the agreed amount shall constitute a complete release from, and bar to, any
and all claims that Plaintiff and/or Plaintiff's counsel may have relating to EAJA attorney fees
and costs in connection with this action.
