1 TO THE HONORABLE COURT:

2 This stipulation is entered into by and between the plaintiffs and the
3 defendants, by and through their respective counsel.

4 1. Pursuant to the Court's April 19, 2016 Scheduling Order, a Settlement
5 Conference is set on July 21, 2017, at 9:30 a.m. before Magistrate Judge
6 Jennifer L. Thurston at the United States District Courthouse located at 510 19th
7 Street, Bakersfield, California.

8 2. The parties have agreed to continue the Settlement Conference to
9 August 4, 2017, at 9:30 a.m. and hereby seek leave for said continuance.
