ORDER

13 A Proposed Final Pretrial Order was filed on December 29, 2017, which identified
14 Exhibits 8, 21, 56, 80, and 120 as either will-offer or may-offer trial exhibits.¹ Defendants
15 identified Exhibit 508 as a will-offer trial exhibit.²

16
17 On March 3, 2017, the Court ordered that “[t]he original of document exhibits shall be
18 delivered to the Clerk of Court.”³

19 Plaintiffs’ filed corrected versions of trial Exhibits 8, 21, 56, 80, and 120 on January 29,
20 2018.⁴ Novartis Pharmaceuticals Corporation filed a corrected version of trial Exhibit 508 on
21 January 22, 2018.⁵ Both parties requested that the previous versions of the exhibits identified be
22 disregarded.⁶
