22 Plaintiff GSF NUT COMPANY, LLC (“GSF”) requests that the Court finds good
 23 cause to continue scheduling conference and extend the deadline to issue a scheduling
 24 order pursuant to Rule 16(b) of the Federal Rules of Civil Procedure.

25 One defendant, HONG KONG BIN GUO INTERNATIONAL TRADING LIMITED
 26 (“Hong Kong”) has been served. GSF has filed a Request for Entry of Judgment for
 27 Sum Certain against Hong Kong, which was subsequently rejected. GSF is currently

2 GSF needs additional time for service on HEBEI YANG YUAN ZHI HUI YIN PIN
3 GU FEN YOU XIAN GONG SI ("Hebei").

4 On January 17, 2017, the appropriate documents were translated into Chinese
5 and mailed to the Ministry of Justice International Legal Cooperation Center in Beijing
6 for Approval of Service.

7 On March 16, 2017, we received an email from the Ministry of Justice of China
8 and were informed that the documents were received and being processed. GSF has
9 been informed that the service could take as long as five (5) months. GSF needs an
10 additional three (3) months to serve Hebei and to allow Hebei to answer.

11 Neither Hong Kong nor Hebei have appeared in this matter.

12 In order to effectuate service on Hebei, GSF requests this Court to find good
13 cause and continue the deadline to file a Scheduling Order to August 3, 2017.
