**ORDER & WRIT OF HABEAS CORPUS AD

(Doc. No. 159)

Abel P. Reyes, CDCR #P 55763, a necessary and material witness in a settlement conference in this case rescheduled from January 13, 2023 to February 27, 2023, is confined in the California Men’s Colony (CMC), in the custody of the Warden. The January 13, 2023 writ is vacated. (Doc. No. 157).
