staffinfection to enter the wound. After I was stripped naked and forced to put on the jump suit a nurse (Doe#5) briefly looked at my arm but didn't allow me to see a doctor orgo to the infirmary. I was housed in a cell on the 6th floor.

My elbow became extreemly red, swelled enormously and began to leak puss. Officers on the 6th floor viewed it as an emergency and called medical. A nurse (Doe#6) came to see me but still didn't Send me to the intirmary to see a doctor and only gave me some motrin for the pain. The motrin didn't even begin to touch the extreem pain that I was in. I went to Court after about 10 days and the judge said that my arm looked like Popeye's arm and seemed to be in extreem pain. I explained what the jail had done to me and he released me that day so I could treat my arm on my own. I was able to clean my wound. and change the dressing daily which relieved alot of the pain, swelling, and redness ... but I was arrested again a week later.

In booking this time I complained to the nurse (Doe#1) and explained to her what had previously happened and how the judge had released me. I even threatened to sue for them culting off my cast and demanded to see a doctor. She (Doe#1) then out of spite ordered the officers to take my medical eye patch if I did not surrender it. I told her the doctor had put it in the alert system of the computer of the jail in 2014 and it was doctor approved." She still took my patch and even removed it from the computer alert system. She undid what the doctor had ordered, even though I explained to her that I have a light sensitive eye and get daily migrains without it. I was not allowed to see a doctor or go to the infirmary for my elbow either which was shill extreemly intected and actively leaking puss.

I went to court and explained every thing to the judge and he ordered me to be seen by a doctor. To this date I had never been seen by a doctor while in the jail. A nurse came to look at my arm and rushed me to the infirmary so a doctor could see. Doctor Burnett ordered immediate I.V. antibiotics

(CLAIM 1 cont.) and moved me to the infirmary. He said he wanted to get the intection before it entered the bone cause I could loose my arm. He couldn't believe they had cut off My cast as a security risk. I was seen by a doctor every day while I was housed in the infirmary and the dressing was changed daily. One week later the night time charge nurse (Doe#8) made the decision without the doctors approval, to remove the I.V. and rehouse me back on the 6th floor because they needed bed space in the infirmary. The infection wasn't even gone yet. I ran into Dr. Burnett on the elevator the next day and told him I was still in extreem pain. He said he couldn't control the moves done by other jail Staft but that "he would take care of me. All he did was prescribe one week of oral antibiotics and pain meds. After one week they both stopped. He could have put me back on I.V. in the infrimary cause he had put me there in the first place, he just chose

not to. I was released a few days after

the medication had stopped. My arm had

Again I was arrested a few days later, but this time the Fresno police officers had me taken in an ambulance to Community hospital. The hospital ran tests on my elbow and said that staff infection had entered the hardware (screws and metal plate) as well as the bone of my elbow. The surgeon could not believe that a medical person would cut off my cast and just leave my wound open. The doctor specializing in intections wanted the plate and all 5 screws removed but during surgery the surgeon said my elbow wasn't healed yet and would fall apart without the hardware. They removed only one screw and put me on I.V. antibiotics for 6 weeks and said there was a 90% Chance the intection would be cured after the 6 weeks without removing the hardware. After one week at Community I was transported to the F.C. J. I told the surgeon how they took my I.V. out after only one week because they needed bed space, so she implanted a "pick line" that

entered my main artery and went straight to my heart makeing it much harder to remove. The pick line was to remain in for the duration of the Gweek antibiotic treatment.

I was released from the jail and the pickline was removed only 2 or 3 weeks into the treatment. Nurse Dulces removed the line. He did not give me any take home pain meds or antibiotics. He also said that he could not tell me when my post surgery appoint ment with my surgeon was. He just told me to go get the pick line

Twas rearrested immediately but this time a nurse in booking recognized me and knew of my situation. She sent me straight to the infirmary and another pick line was implanted. But again I was released and the pick-line was removed only 2 or 3 weeks into the treatment. Once again I was not given any medication for pain or anitibiotics to take home and only told to get the pick line put back in as soon as possible. This time I was finally able to get medical but the very next day I was arrested again.

It was now 6-30-16 when I was arrested. The jail doctor said I had built up an immunity to the antibiotics and schedualed me to see an outside surgeon so they could decide how to proceed with my treatment. I was in extreem pain for about a month and finally after I filed a grievance, I was taken to the outside clinic on 8-1-16. My elbow was Seen and x-rayed at the clinic. The doctor prescribed antibiotics and pain meds for the infection in my elbow which was still leaking puss. The surgeon wanted me to take the medications for two weeks and then come back to set up a possible surgery date.

When I got back to the jail they never honored the prescriptions. I guess the Dr. on duty (Doe#9) decided not to fill the prescriptions that the surgeon sent back with me. I was sent back to my cell with nothing. I remained in pain with an infection that wasn't being treated. I complained everyday and put in medical slips and even filed a grievance to no avail.

Two weeks later on 8-15-16 I finally saw a doctor at the nurses line (Doe#10). I explained that the surgeon had sent me back with prescriptions of antibiotics and pain meds but they were never given to me. He said he would check my file and the meds would start that night if this were true. That night the antibiotics came but he did not honor her pain med prescription, so I remained in pain,

In pain,
A week later on 8-22-16 I finally went back to outside medical. She told me to continue with the meds and come back in a few days for surgery. On 8-30-16 I went to surgery. When I came out of general anesthesia I was in extreem, un bearable pain, and literally woke up screaming. The nurse put morphine into my I.V. and 15 minutes later the pain began to subside. It was still very painful and I was already begining to worry about the pain once I got back to the jail. I had no faith in the jail medical and told the surgeon they would not honor her prescriptions.

(CLAIM 1 cont.)

The surgeon called the jail right in front of me and the 2 officers escourting me to make sure they would give me what she prescribed. They assured her I would get the Norco for pain (Which the surgeon said was stronger than Tylenol w/codine) and antibiotics. When I got back to the jail the doctor on duty (Doe#11) decided to prescribe me the antibiotics but not the norco for pain. The only thing I was given for pain was 225 miligram motrin, which did nothing for the extreem pain I was in. I had just gotten my elbow opened up, had a plate with 5 screws removed, and had the bone scrapped clean of any infection still left on the bone. I had 10 staples that closed a 41% inch incision that went across the bend of my elbow. It was the most intense, extreem pain I've ever experienced in my life and he wouldn't even give me What the surgeon prescribed for pain. I couldn't even sleep the pain was so horrible.

They didn't even change the dressing until 5 days later after I complained to the med nurses. I guess (Doe#11) hadn't put in that Order either. Nurse Terry at the first changing on 9-4-16 said it was very red and swollen and she would tell the doctor and try to get the meds that were prescribed for pain. She couldn't believe I was only given motrin. On 9-6-16 at the next changing, nurse Samantha Said, "Yeah it looks like its very painfull." She also said she would fell the doctor and try to get my pain meds started. On 9-7-16 and 9-8-16 other nurses changed the dressing, each one saying they would tell the doctor that I need the pain meds prescribed to me.

This was pure torture. I couldn't believe another human would put me through this pain. It became a mental delima. I had almost lost my arm and underwent 6 months of pain because they cut off my cast and gave me a staff infection in my wound, and now it was like the climax of pain. This was beyond cruel and unusual punishment, it was flat out torture. On 9-9-16 after 10

days of this I was seen by Dr. Burnett who prescribed me codine #4's and the pain was finally alieved. He told me he had been on vacation for a month and wasn't aware

Of what was going on with me.

I was getting the codine #4's still and my release date came up. This time I persisted about my 'take-home' meds cause I had learned that we have a right to them. They told me to go to CVS on the fulton mall, Cvs calls the jail and then they give me a one week supply. I went straight to CVS and they called the jail but told me "the jail didn't have anything for me." I was arrested 3 days later on 9-29-16. Iwas assaulted by 4 officers (maldinado, Does 12,13 & 14) as explained in claim two of this complaint. The 4 officers who assaulted me and the Sergent (Doe#15) who filmed me did not allow me to get examined by a doctor for my injuries. All the Sergent did was offer me water.

Even after I was released from the chair 8 hours later I was not seen by a doctor or taken to the intirmary. I had huge lumps on my forehead, a broken nose that was split open actively bleeding, a split eyebrow actively bleeding,

a cracked tooth, and bruised ribs. Nurse Teressa looked at me afterwards through the glass and asked if I had went to the outside hospital for my injuries. I told her no "I haven't even seen a doctor," She shook her head in disgust, I explained how I was on codine #4's for my elbow still and didn't get anything when I' was released for 3 days, but especially needed them now for these new injuries as well. She Checked the computer and said the codine#4 perscription should still be good. She told me that an ice pack for my new injuries and my pain meds would follow me upstairs. Once again whatever doctor was on duty Doe#16) did not redo my codine and did not send the ice

I remained in extreem pain and complained daily to the med nurses that I never got my codine and ree packs that I was supposed to get. I also had at least 5or 6 officers call medical for me over the pain I was in for these new injuries. The trama to my head caused unbearible headaches everytime I woke up. I literally slept for over two weeks straight. I began to get worried that some permanent damage had been done to my head. I am still worried as the headaches etill comedaily. For sure I have a

a concussion... I know the symptoms cause I've had 2 or 3 from automobile accidents, but none as painful as this. I couldn't hardly move or breath from my bruised ribs, which still hurt to move. The broken tooth which started out hot too painful became the most painful of all once bacteria entered the molar and an abcess formed. Not to mention my elbow which is still very painfull with limited movement. I put in numerous medical slips and filed grievances to no avail.

A little over I weeks later one of my grievances was finally sustained and I was put on the nurses line. The nurse (Doe#17) came to see me. She told me my ribs had been bruised. She also said she would schedual me to see the doctor for the head injuries and headaches and schedual me to see the dentist for my cracked tooth. I told her how I couldn't even eat anymore due to the swelling and how all of these injuries cause extreem pain. She said nothing could really be done about the broken nose. All she did was prescribe me motrin for one week which did nothing for the pain. She said only a doctor could give me something stronger. I asked her if I could go

to the infirmary to see a doctor that day as the nurse had done months prior for my elbow but she wouldn't. She did check the computer for my eyepatch and said "someone" took it off the alert system in March of 2016. I was sent back to my cell and remained in extreem pain, as the motrin did nothing for

The pain I was experiencing.

I never went to the doctor or the dentist. I got lucky and caught the dental assistant, about a week later, up on the floor. I called her to my cell and showed her the swollen iaw and broken tooth. This was on a Friday and she told me there was nothing she could do that day, but 3 days later on Monday, when the dentist came back, I was called to dental just as the assistant said she would. When the dentist saw the X-rays of my molar she Said the tooth had been tractured which allowed bacteria to enter it and it became abcessed. She said it looked pregnant with puss. Dr. Nuygen immediately extracted the molar, finally ending the weeks of pain and suffering. She showed me the molar and how it was broken from the 9-29-16 assault. I couldn't Keep the tooth for exidence.

They threw me to the ground and cuffed me behind my back, then bashed my head into the concrete numerous times. I couldn't even tell which ones were punches and which blows were kicks cause I was getting hit all over. I was leaking blood from two areas on my face and began seeing it drip onto the ground befor they stopped. Two of them left and came back with a Sergent (Doe #15) and a chair. They uncuffed me and strapped me to the chair for 8 hours. The Sergent Almed them uncuff me and then Strap me into the chair. I continued to leak blood for 8 hours in the chair. It was like some crazy form of torture as the blood tickled the tip of my nose as it dripped off, yet I was totally unable to scratch it or wipe of the blood. I couldn't do anything but sit there in extreem pain from the beating I had just recieved. They split my nose (Ithink it was broken) it is scared and
