ORDER GRANTING STIPULATION TO  
CONTINUE CERTAIN SCHEDULED DATES

(Doc. Nos. 29, 30)

21 On October 4, 2017, the parties filed a joint stipulation to continue the Pretrial Conference  
22 and Trial dates in this action. (Doc. No. 29.) On September 18, 2017, the court issued a minute  
23 order continuing the pre-trial conference to November 20, 2017 at 1:30 p.m. and jury trial to  
24 January 23, 2018 at 8:30 a.m. (Doc. No. 28.) However, these dates pose a direct conflict with  
25 defendants' counsel's schedule who has previously been set for a jury trial on January 23, 2018 in  
26 another civil lawsuit, *Lauris v. Novartis AG, et al.*, 1:16-cv-00393-SEH, in the Eastern District of  
27 California. (Doc. No. 29 at 2, ¶ 7.) As such, the parties propose continuing the pre-trial  
28 conference to May 29, 2018 and jury trial to July 24, 2018. Based on the stipulation, neither

1 party will be prejudiced by the proposal nor will any other dates established in the amended  
2 scheduling order (Doc. No. 14) be disturbed.

3 Accordingly, for good cause shown and in light of the parties' stipulation, the court will  
4 amend the schedule in this case as follows:

- 5 1. The pre-trial conference previously set for November 20, 2017 at 1:30 p.m. is now  
6 continued to May 21, 2018 at 1:30 p.m.<sup>1</sup>
- 7 2. The jury trial previously set for January 23, 2018 at 8:30 a.m. is now continued to  
8 July 24, 2018 at 8:30 a.m.

9 IT IS SO ORDERED.
