**STIPULATION TO EXTEND DEADLINE TO  
FILE DISPOSITIONAL DOCUMENTS;  
ORDER**

22 Plaintiff MICHAEL CHARLES BEIDLEMAN, et al. ("Plaintiffs") and Defendant CITY OF  
23 MODESTO ("Defendant"), by and through their respective counsel, hereby stipulate as follows:

- 24 A. WHEREAS, the parties held a settlement conference before the Honorable Magistrate  
25 Judge Stanley A. Boone on May 23, 2017.
- 26 B. WHEREAS, the Court issued an Order following settlement directing the parties to file  
27 dispositive documents and a joint settlement for approval within 60 days, or on or before  
28 July 24, 2017 (Dkt. No. 48);

- 1 C. WHEREAS, the parties have been working diligently towards finalizing the terms of the  
2 settlement and memorializing them in a signed, written settlement agreement;
- 3 D. WHEREAS, the parties require additional time to finalize the written settlement  
4 agreement and collect approval and signatures from their respective clients;
- 5 E. The parties respectfully request an additional 30 days to comply with the court's May 23,  
6 2017 Order.

7 NOW THEREFORE, Plaintiff and Defendant stipulate and request that:

8 1. It is in the interest of the Court and the parties to continue the deadline to file dispositional  
9 documents and a joint settlement for approval by this Court for 30 days, or until August 23, 2017. No  
10 party will be prejudiced by an extension of this deadline.
