14 In each of the cases listed in the caption, the plaintiff complains that each of the defendants  
15 acted/failed to act in nearly the identical, if not the identical, manner related to compliance with the  
16 Americans with Disabilities Act.

17 The Court's review of the cases reveals that the actions are related, as that term is defined in  
18 Local Rule 123. The actions involve overlapping questions of law and fact and are based on the same
