16 The Motion For A Stay Pending The Judicial Panel On Multidistrict Litigation's Resolution Of
17 The Motion To Transfer Pursuant To 28 U.S.C. § 1407 submitted by Plaintiff Sharron Thomas
18 ("Plaintiff") on June 28, 2017, the Court, having received all evidence and the matter having been
19 submitted, ORDERS as follows:

20 **IT IS HEREBY ORDERED** that:

21 1. All proceedings in this action are stayed pending the decision of the Judicial Panel on
22 Multidistrict Litigation ("JPML") On the Motion for Transfer filed on June 2, 2017 to transfer this
23 action and one hundred sixty-five others to a multidistrict litigation, which be established in the United
24 States District Court Of New Jersey. See Ex. 1, Memorandum in Support of Plaintiffs' Motion for

1 Transfer of Actions to the United States District Court for the District of New Jersey Pursuant to 28
2 U.S.C. § 1407 and JPML Rule 7.2 for Coordinated Pretrial Proceedings; and Ex. 2, In re: Proton-Pump
3 Inhibitor Product Liability Litigation (MDL No. 2789), Schedule of Actions.

4 2. The Scheduling Conference set for July 24, 2017, along with corresponding deadlines for the
5 parties to meet and confer and submit a Joint Scheduling Report in advance of the Scheduling
6 Conference, is adjourned, including a stay of all corresponding deadlines for the parties to hold a
7 discovery conference and submit a Joint Scheduling Report, until after the JPML decides the motion
8 requesting an MDL.
