17	Mario Gonzalez ("Plaintiff") is a state prisoner proceeding pro se and in forma pauperis	
18	in this civil rights action filed pursuant to 42 U.S.C. § 1983.	
19	On July 2, 2018, Plaintiff filed a letter indicating that he had retained attorney Stanley	
20	Silver to represent him in this case. (ECF No. 124). On September 4, 2018, Plaintiff filed a	
21	request for the Court to allow him to speak with his attorney via telephone or to have a hearing on	
22	the matter. (ECF No. 137).	
23	Also pending is Defendants' motion for summary judgment, which was filed on June 25	
24	2018. (ECF No. 123). Plaintiff has still not opposed that motion.	
25	The Court therefore sets a hearing to discuss the status of the case, in order to determine it	
26	Plaintiff is represented and to confirm whether Plaintiff intends to oppose the pending motion for	
27	summary judgment.	
28	Additionally, the Court will send a copy	y of this order to Stanley Silver, so that he may

1	appear at the hearing and inform the Court whether he represents Plaintiff in this matter. If he	
2	does, and if he wants to have a confidential telephone conversation with Plaintiff, he may reques	
3	such relief on the record at the hearing.	
4	Accordingly, IT IS ORDERED that:	
5	1. A status conference is set for September 24, 2018, at 1:30 PM, in Courtroom 10,	
6	before Magistrate Judge Erica P. Grosjean. To appear telephonically, each party is	
7	to use the following dial-in number and passcode: Dial-in number 1-888-251	
8	2909; Passcode 1024453;	
9	2. Plaintiff shall make arrangements with staff at his institution of confinement for	
10	his attendance at the conference. Plaintiff's institution of confinement shall make	
11	Plaintiff available for the conference at the date and time indicated above. Prior to	
12	the conference, defense counsel shall confirm with Plaintiff's institution of	
13	confinement that arrangements have been made for Plaintiff's attendance; and
