1 **ORDER**

2 On August 31, 2017, the parties filed a stipulation to dismiss this action with
3 prejudice. (ECF No. 40). All parties have agreed to the dismissal. *Id.* In light of the stipulation, the
4 case has ended and is dismissed with prejudice. *See* Fed. R. Civ. P. 41(a)(1)(A)(ii); *Wilson v. City of*
5 *San Jose*, 111 F.3d 688, 692 (9th Cir. 1997); *Concha v. London*, 62 F.3d 1493, 1506 (9th Cir. 1995)
6 (“Even if the defendant has filed a motion to dismiss, the plaintiff may terminate his action
7 voluntarily by filing a notice of dismissal under Rule 41(a)(1).”). Accordingly, the Clerk of the Court
8 is DIRECTED to close this case.
