19 Plaintiff Carmen Teresa Osborne and Defendant Nancy A. Berryhill, Acting
20 Commissioner of Social Security, through their undersigned attorneys, stipulate,
21 subject to this court's approval, to extend the time by 35 days from August 18,
22 2017 to September 22, 2017 for Plaintiff to file an Opening Brief, with all other
23 dates in the Court's Order Concerning Review Of Social Security Cases extended

1 This is Plaintiff's first request for an extension. Plaintiff's counsel's mother
