Pursuant to 28 U.S.C. § 636(c), Plaintiff consented to the jurisdiction of the United States 20 Magistrate Judge on February 6, 2017. Local Rule 302. 21 On January 17, 2017, in case number 1:17-cv-00058 SAB PC, Cramblit v. California Dep't of 22 Corrections and Rehabilitation, the Court issued an order striking the complaint for lack of Plaintiff's 23 signature, and directed Plaintiff to file a signed complaint within thirty days. (1:17-cv-00058 SAB PC, 24 ECF No. 12.) The thirty days has expired and no amended complaint was filed in that action. 25 However, the instant action was filed and opened on January 25, 2017. 26 The Court has reviewed the complaints in both actions and finds that both involve the same 27 cause of action, and the complaint filed in this action was intended to be filed as an amended

complaint in case number 1:17-cy-00058 SAB PC. Therefore, this action was opened in error due to

7	amended complaint in case number 1:17-cv-00058 SAB PC; and
8	3. The Clerk of Court is directly to administratively close this action.
