18 **WHEREAS**, Plaintiff Rachel Bryant (“Plaintiff”), and Defendants, Tanya Tovar dba

20 (“Defendants,” and together with Plaintiff, “the Parties”), previously entered into a stipulation  
21 granting Defendants to and including June 5, 2017 to file responsive pleadings in this matter

23 **WHEREAS**, a Mandatory Scheduling Conference in this matter is set for June 13, 2017

26 settlement can be reached informally, and desire to conserve attorney’s fees which would be

1           **NOW, THEREFORE**, the Parties, by and through their respective counsel, stipulate to  
2 a continuance of the Mandatory Scheduling Conference currently set for June 13, 2017 to a date  
3 at the Court's convenience on or after July 13, 2017. The Parties additionally stipulate to a  
4 further extension of time for Defendants' responsive pleadings, such that the responsive  
5 pleadings be filed on or before July 5, 2017.
