18	Plaintiff is a prisoner proceeding pro se with this civil rights action filed pursuant to 42	
19	U.S.C. § 1983, and has requested leave to proceed in forma pauperis pursuant to 28 U.S.C.	
20	§ 1915. Plaintiff has made the showing required by § 1915(a). Accordingly, the application to	
21	proceed in forma pauperis will be granted. Plaintiff is obligated to pay the statutory filing fee of	
22	\$350.00 for this action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to make monthly payments	
23	in the amount of twenty percent of the preceding month's income credited to Plaintiff's trust	
24	account. Fresno County Jail is required to send to the Clerk of the Court payments from	
25	Plaintiff's account each time the amount in the account exceeds \$10.00, until the statutory filing	
26	fee is paid in full. 28 U.S.C. § 1915(b)(2).	
27	In accordance with the above and good cause appearing therefore, IT IS HEREBY	
28	ORDERED that:

1	1. Plaintiff's application to proceed in forma pauperis is GRANTED;	
2	2. The Sheriff of the Fresno County Jail or his designee shall collect payments	
3	from Plaintiff's prison trust account in an amount equal to twenty per cent (20%) of	
4	the preceding month's income credited to the prisoner's trust account and shall	
5	forward those payments to the Clerk of the Court each time the amount in the	
6	account exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of	
7	\$350.00 has been collected and forwarded to the Clerk of the Court. The payments	
8	shall be clearly identified by the name and number assigned to this action.	
9	3. The Clerk of the Court is directed to serve a copy of this order and a copy of	
10	Plaintiff's application to proceed in forma pauperis on the Sheriff of the Fresno County	
11	Jail, via the court's electronic case filing system (CM/ECF).	
12	4. The Clerk of the Court is directed to serve a copy of this order on the Financial	
13	Department, U.S. District Court, Eastern District of California, Sacramento Division.	
14	5. Within sixty (60) days of the date of service of this order, Plaintiff shall submit a	
15	certified copy of his prison trust account statement for the six-month period immediately	
16	preceding the filing of the complaint, if Plaintiff has not already done so.	
17	IT IS SO ORDERED.
