17	Donald Williams ("Plaintiff") is a st	ate prisoner proceeding pro se with this civil rights
18	action filed pursuant to 42 U.S.C. § 1983. On June 26, 2017, Plaintiff filed a motion for an order	
19	for the defendants to show cause why Plaintiff's application(s) submitted to proceed in forma	
20	<ul> <li>pauperis were not mailed to the Court ("the Motion"). (ECF No. 10).</li> <li>According to Plaintiff, on April 27, 2017, he submitted an application to proceed in forma</li> <li>pauperis to the Salinas Valley State Prison ("SVSP") Trust Office, for the purpose of obtaining a</li> <li>certified copy of Plaintiff's prison trust account statement. Plaintiff included instructions for the</li> <li>application to be mailed to the Court after the trust account statement was attached. Plaintiff did</li> </ul>

25	not hear back (even after asking the Trust Office to confirm that the in forma pauperis application	
26	was received and mailed to the Court), so Plaintiff submitted another application to proceed in	
27	forma pauperis to the Trust Office on May	y 16, 2017. Plaintiff once again did not receive a

1	response. Accordingly, Plaintiff asks that "[t]he defendants or SVSP Trust [O]ffice personnel or		
2	Plaintiff's assigned counselor C. Ramos be ordered by the Court to show cause why		
3	Plaintiff's application[s] submitted to the SVSP Trust Office personnel to proceed in forma		
4	pauperis were not mailed to the Court."		
5	The Court will not grant Plaintiff's request at this time. The individual defendants in this		
6	case do not appear to be the ones with Plaintiff's papers. Moreover, Plaintiff should complete an		
7	in forma pauperis application and submit it directly to the Court. If he is unable to get a copy of		
8	his trust account statement, he may file evidence (in the form a declaration) explaining why he is		
9	unable to get it. <sup>1</sup>		
10	Accordingly, based on the foregoing, IT IS HEREBY ORDERED that:		
11	1. The Motion is DENIED;		
12	2. The Clerk of Court is directed to send Plaintiff an application to proceed in forma		
13	pauperis;		
14	3. Plaintiff has thirty days from the date of service of this order to complete and		
15	return the attached application to proceed in forma pauperis. If Plaintiff is unable		
16	to get a copy of his prison trust account statement, he may file evidence (in the		
17	form a declaration) explaining why he is unable to get it;		
18	4. The Clerk's Office shall serve a copy of this order on Deputy Attorney General		
19	Monica Anderson at the Attorney General's Office; and		
20	5. Failure to comply with this order will result in dismissal of this action.		
21	IT IS SO ORDERED.		
22	II IS SO ORDERED.
