1	In accordance with the above and good cause appearing therefore, IT IS HEREBY	
2	ORDERED that:	
3	1. Plaintiff's application to proceed in forma pauperis is GRANTED;	
4	2. The Sheriff of the Fresno County Jail or his designee shall collect payments	
5	from plaintiff's prison trust account in an amount equal to twenty per cent (20%) of	
6	the preceding month's income credited to the prisoner's trust account and shall	
7	forward those payments to the Clerk of the Court each time the amount in the	
8	account exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of	
9	\$350.00 has been collected and forwarded to the Clerk of the Court. The payments	
10	shall be clearly identified by the name and number assigned to this action.	
11	3. The Clerk of the Court is directed to serve a copy of this order and a copy of	
12	plaintiff's in forma pauperis application on the Sheriff of the Fresno County Jail, via the	
13	court's electronic case filing system (CM/ECF).	
14	4. The Clerk of the Court is directed to serve a copy of this order on the Financial	
15	Department, U.S. District Court, Eastern District of California, Sacramento Division.	
16	5. Within sixty (60) days of the date of service of this order, plaintiff shall submit a	
17	certified copy of his prison trust account statement for the six-month period immediately	
18	preceding the filing of the complaint, if plaintiff has not already done so.
