OF INMATE FILING FEE BY THE SHERIFF 16 OF STANISLAUS COUNTY 17 18 Plaintiff is a prisoner proceeding pro se in this civil rights action filed pursuant to 42 19 20 U.S.C. § 1983, and has requested leave to proceed in forma pauperis pursuant to 28 U.S.C. 21 § 1915 (ECF No. 2). Plaintiff has made the showing required by § 1915(a)(1), and accordingly, 22 the request to proceed in forma pauperis will be granted. Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to 23 make monthly payments in the amount of twenty percent of the preceding month's income 24 credited to Plaintiff's trust account. The Sheriff of Stanislaus County is required to send to the 25 26 Clerk of Court payments from Plaintiff's account each time the amount in the account exceeds 27 \$10.00, until the statutory filing fee is paid in full. 28 U.S.C. § 1915(b)(2). In accordance with the above and good cause appearing therefore, IT IS HEREBY 28 1

ORDERED that: 2 1. Plaintiff's application to proceed in forma pauperis is GRANTED; 2. The Sheriff of Stanislaus County or his designee shall collect payments from 3 Plaintiff's prison trust account in an amount equal to twenty per cent (20%) of the 4 preceding month's income credited to the prisoner's trust account and shall forward 5 those payments to the Clerk of Court each time the amount in the account exceeds 6 \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of \$350.00 has been 7 collected and forwarded to the Clerk of Court. The payments shall be clearly 8 identified by the name and number assigned to this action. 9 3. The Clerk of Court is directed to serve a copy of this order and a copy of Plaintiff's 10 application to proceed in forma pauperis on the Sheriff of Stanislaus County, via mail at 11 250 E Hackett Road, Modesto, CA 95358. 12 4. The Clerk of Court is directed to serve a copy of this order on the Financial 13 Department, U.S. District Court, Eastern District of California, Sacramento Division. 14 5.
