1 Pursuant to Plaintiff Fatemeh Saniefar and Defendants Ronald Moore, Tanya E. Moore,
2 Kenneth Randolph Moore, Marejka Sacks, Elmer Leroy Falk, Moore Law Firm, Mission Law
3 Firm, Geoshua Levinson, Rick D. Moore, West Coast CASP and ADA Services, and Ronny
4 Loreto (collectively, “the Parties”) jointly notifying the Court that the above referenced matter has
5 been resolved in its entirety as of October 20, 2019, and good cause appearing therefore, **IT IS**
6 **HEREBY ORDERED** that:

- 7 1. The Parties are given to and including February 3, 2020, within which to file the Joint
8 Stipulation for Dismissal with Prejudice to allow time for certain conditions of the
9 agreement to be met.
- 10 2. The Court sets a Settlement Disposition Conference (“the Conference”) on **February**
11 **5, 2020, at 9:00 A.M. in Courtroom 8 (BAM) before Magistrate Judge Barbara A.**
12 **McAuliffe**. The Parties may appear at the conference by telephone with each party

15 Joint Stipulation for Dismissal with Prejudice in advance of the Conference; and
- 16 3. The Court VACATES all other pending dates and matters.
