



1       **WHEREAS**, on December 1, 2017, the Court granted the motions of Defendants  
2 Kenneth Randolph Moore, Geoshua Levinson, West Coast CASp & ADA Services, Rick D.  
3 Moore; Tanya E. Moore, Zachary M. Best (erroneously sued herein as “Zachery M. Best”),  
4 Mission Law Firm, Moore Law Firm, Ronald D. Moore, Ronny Loreto, Elmer LeRoy Falk, and  
5 Marejka Sacks (collectively referred to herein as “Defendants”) to dismiss the Complaint filed  
6 by Plaintiff Fatemeh Saniefar (“Plaintiff,” and together with Defendants, “the Parties”) with  
7 leave to amend and allowing Plaintiff 20 days from the date of the order to file an amended  
8 complaint (Dkt. 29);

9       **WHEREAS**, Plaintiff’s amended complaint would therefore be due on December 21,  
10 2017, and pursuant to Federal Rule of Civil Procedure 15(a)(3), Defendants’ responsive  
11 response would be due within 14 days or by January 4, 2018; and

12       **WHEREAS**, the Parties have agreed to an alternative briefing schedule in light of the  
13 holidays and counsels’ availability.

14       **NOW, THEREFORE**, the Parties, by and through their respective counsel, stipulate  
15 that the time for Plaintiff to file her amended complaint be extended from December 21, 2017  
16 to January 3, 2018, and that Defendants’ response to the amended complaint be filed on or  
17 before January 19, 2018.
