2	should not dismiss this case for failure to comply with a court order. Alternatively, the Plaintiff
3	can file a notice, within 14 days, advising the Court whether Plaintiff received documents
4	responsive to the subpoena, and if so, identifying Jane Doe in order to effect service.
5	Failure to comply with this Order will result in a recommendation of dismissal of the
6	action for failure to obey a court order.
