1 Before the Court is Plaintiff United States of America (“Plaintiff”)’s Request to Extend the
2 Deadline to Submit a Joint Status Report. (Doc. 30.) Plaintiff seeks to extend the deadline from January
3 17, 2018, to March 17, 2018, in order to allow (1) all potential claimants to enter the case if they so
4 choose; (2) the statutory period for Defendant’s wife to file a claim to expire; and (3) Plaintiff to
5 continue coordinating with the relevant foreign governments to prosecute this case. (*Id.*) For good
6 cause shown, IT IS ORDERED that the deadline for the parties to file a joint status report in this case, in
7 accordance with the Court’s prior order entered on December 21, 2017 (Doc. 20), is hereby extended
8 from January 17, 2018, to March 17, 2018.

9 IT IS FURTHER ORDERED that the Scheduling Conference currently set for March 6, 2018, is
10 hereby continued to June 12, 2018, at 9:30 a.m. in Courtroom 7 before the undersigned. The parties
11 shall file a Joint Scheduling Report by no later than June 5, 2018.
