 20 IT IS HEREBY STIPULATED, by and between the parties, through their respective
 21 counsel of record, that this action be remanded to the Commissioner of Social Security for
 22 further administrative action pursuant to section 205(g) of the Social Security Act, as amended,
 23 42 U.S.C. § 405(g), sentence four.

24 On remand, the Appeals Council will assign this case to an administrative law judge
 25 (ALJ) for a new hearing and decision. The Appeals Council will instruct the ALJ to fully
 26 develop the record, including, but not limited to, give further consideration to the medical
 27 opinions of record, including that of Idelfonso Cruz, M.D.; reevaluate the claimant's residual
 28 functional capacity; and obtain vocational expert evidence, if necessary.

1 The parties further request that the Clerk of the Court be directed to enter a final
2 judgment in favor of Plaintiff, and against Defendant, reversing the final decision of the
3 Commissioner .
