ORDER VACATING ORDER GRANTING
PLAINTIFF'S APPLICATION TO
PROCEED IN FORMA PAUPERIS AND
REVOKING PLAINTIFF'S IN FORMA
PAUPERIS STATUS
(ECF NOS. 2 & 9)

ORDER REQUIRING PLAINTIFF TO PAY
\$400.00 FILING FEE IN FULL WITHIN
THIRTY DAYS

18 Kasey Hoffmann ("Plaintiff") is a state prisoner proceeding *pro se* and *in forma*
19 *pauperis* with this civil rights action filed pursuant to 42 U.S.C. § 1983. The matter was
20 referred to a United States magistrate judge pursuant to 28 U.S.C. § 636(b)(1)(B) and Local
21 Rule 302.

22 On March 27, 2018, Magistrate Judge Erica P. Grosjean entered findings and
23 recommendations, recommending that the order granting Plaintiff's application to proceed in
24 forma pauperis (ECF No. 9) be vacated, that Plaintiff's *in forma pauperis* status in this action
25 be revoked, and that Plaintiff be required to pay the \$400 filing fee in full if he wants to
26 proceed with this action. (ECF No. 10).

27 Plaintiff was given an opportunity to object to the findings and recommendations. The
28 deadline for filing objections has passed, and Plaintiff has not filed objections or otherwise

1 responded to the findings and recommendations.

2 In accordance with the provisions of 28 U.S.C. § 636(b)(1)(B) and Local Rule 304, this
3 Court has conducted a de novo review of this case. Having carefully reviewed the entire file,
4 the Court finds the findings and recommendations to be supported by the record and proper
5 analysis.

6 Accordingly, IT IS ORDERED that:

- 7 1. The findings and recommendations issued by the magistrate judge on March 27,
8 2018, are ADOPTED IN FULL;
- 9 2. The order granting Plaintiff's application to proceed in forma pauperis (ECF No.
10 9) is VACATED and Plaintiff's *in forma pauperis* status in this action is
11 REVOKED;
- 12 3. Plaintiff shall pay the \$400 filing fee in full within thirty days from the date of
13 service of this order if he wants to proceed with this action; and
- 14 4. Failure to pay the filing fee within thirty days from the date of service of this
15 order will result in the dismissal of this action.
