22 THE PARTIES HEREBY STIPULATE, through their undersigned attorneys and with the
23 approval of the Court, that Defendant has agreed to a voluntary remand of this case pursuant to sentence
24 four of 42 U.S.C. § 405(g).

25 Upon remand, the Appeals Council will remand this case to an administrative law judge (ALJ)
26 and direct him or her to issue a new decision. The ALJ will reevaluate the examining medical source
27 opinion of Emanuel Dozier, M.D. The ALJ will also reevaluate whether Plaintiff was able to perform
28 her past relevant work.

1 As noted, this stipulation constitutes a remand under the *fourth sentence* of Section 205(g) of the
2 Social Security Act. 42 U.S.C. § 405(g).
