17 DeFilippo, et al. v. County of Stanislaus, et al., Case No. 1:18-cv-00496 DJC-KJN,
18 Eduardo Quintanar, Jr. v. County of Stanislaus, et al., Case No. 1:18-cv-01403 DJC-
19 KJN, Estate of Frank Carson and Georgia DeFilippo v. County of Stanislaus, Case No.
20 1:20-cv-00747 DJC-KJN, and Walter W. Wells, et al. v. County of Stanislaus, et al.,
21 Case No. 1:20-cv-00770 DJC-KJN are hereby consolidated;

22 2. Case No. 1:15-cv-00311 DJC-KJN is designated as the "master file;"

23 3. The Clerk of the Court is DIRECTED to add all complaints and answers
24 filed in Case Nos. 1:18-cv-00496 DJC-KJN, 1:18-cv-01403 DJC-KJN, 1:20-cv-00747
25 DJC-KJN, and 1:20-cv-00770 DJC-KJN to the master file;

26 4. The Clerk of the Court is DIRECTED to administratively close Case Nos.
27 1:18-cv-00496 DJC-KJN, 1:18-cv-01403 DJC-KJN, 1:20-cv-00747 DJC-KJN, and 1:20-
28 cv-00770 DJC-KJN;

1 5. The parties are directed to file all future pleadings, motions and other
2 filings ONLY in Case No. 1:15-cv-00311 DJC-KJN; and

3 6. All remaining defendants have file answers to the operative complaints
4 in Case No. 1:15-cv-00311 DJC-KJN (ECF Nos. 215 and 218), Case No. 1:18-cv-00496
5 DJC-KJN (ECF Nos. 116 and 134), Case No. 1:18-cv-01403 DJC-KJN (ECF Nos. 85 and
6 103), and Case No. 1:20-cv-00770 DJC-KJN (ECF Nos. 98 and 99). Defendants
7 County of Stanislaus, City of Modesto, Birgit Fladager, Marlissa Ferreira, David Harris,
8 Kirk Bunch, Steve Jacobson, Jon Evers, and Cory Brown shall file responsive pleadings
9 to the operative complaint related to Case No. 1:20-cv-00747 DJC-KJN within
10 fourteen (14) days after service of the Third Amended Complaint (ECF No. 90) –
11 October 17, 2023. Fed. R. Civ. P. 15(a)(3).
