17	Plaintiff Edward Wayne Mason ("Plaintiff") is a county jail inmate appearing pro se in	
18	this civil rights action pursuant to 42 U.S.C. § 1983. Plaintiff initiated this action on May 17,	
19	2018, together with a motion to proceed in forma pauperis pursuant to 28 U.S.C. § 1915. (ECF	
20	No. 2.)	
21	Plaintiff has made the showing required by § 1915(a) and accordingly, the request to	
22	proceed <i>in forma pauperis</i> will be granted. Plaintiff is obligated to pay the statutory filing fee of	
23	\$350.00 for this action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to make monthly payments	
24	in the amount of twenty percent (20%) of the preceding month's income credited to Plaintiff's	
25	trust account. The Fresno County Jail is required to send to the Clerk of the Court payments from	
26	Plaintiff's trust account each time the amount in the account exceeds \$10.00, until the statutory	
27	filing fee is paid in full. 28 U.S.C. § 1915(b)(2).

1	Accordingly, IT IS HEREBY ORDERED that:	
2	1. Plaintiff's application to proceed in forma pauperis (ECF No. 2) is GRANTED;	
3	2. The Sheriff of Fresno County Jail or her designee shall collect payments from	
4	Plaintiff's prison trust account in an amount equal to twenty per cent (20%) of the	
5	preceding month's income credited to the prisoner's trust account and shall forward	
6	those payments to the Clerk of the Court each time the amount in the account	
7	exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of \$350.00 has	
8	been collected and forwarded to the Clerk of the Court. The payments shall be	
9	clearly identified by the name and number assigned to this action;	
10	3. The Clerk of the Court is directed to serve a copy of this order and a copy of	
11	Plaintiff's in forma pauperis application on the Sheriff of the Fresno County Jail, via the	
12	Court's electronic case filing system (CM/ECF); and	
13	4. The Clerk of the Court is directed to serve a copy of this order on the Financial	
14	Department, U.S. District Court, Eastern District of California.
