ORDER SETTING SETTLEMENT
CONFERENCE AND PARAMETERS AND
SCHEDULING PRE-CONFERENCE
TELEPHONIC DISCUSSION

Settlement Statements due: February 17, 2023
Pre-settlement Conference: February 24, 2023
Settlement Conference: March 3, 2023

Magistrate Judge Helena Barch-Kuchta will hold a settlement conference on **March 3, 2023, at 10:30 a.m.** via video teleconference. The Zoom settlement conference invitation will be distributed the week prior.¹ The court has reserved the entire day for this settlement conference and expects the parties will proceed with the settlement conference in good faith and attempt to resolve all or part of the case. If any party believes that the settlement conference will not be

1 productive, that party shall so inform the court as far in advance of the settlement conference as
2 possible.

3 Unless otherwise permitted in advance by the court, the following individuals must attend
4 the settlement conference in person: (1) all of the attorney(s) who will try the case; and (2)
5 individuals with full authority to negotiate and settle the case, on any terms. *See* Local Rule 270(f).
6 ***Whether one or more of the named defendants' attendance will be required will be discussed at***
7 ***the February 24, 2023, Pre-Settlement Telephone Conference.***

8 **No later than February 17, 2023**, each party must submit to Judge Barch-Kuchta's
9 chambers at hbkorders@caed.uscourts.gov or by mail at U.S. District Court, P.O. Box 575,
10 Yosemite National Park, CA 95389, a settlement conference statement. These statements should
11 neither be filed on the docket nor served on any other party.

12 In compliance with Local Rule 270(d)-(e), the settlement statements will be used
13 exclusively for the undersigned to prepare for and conduct the settlement conference. They will
14 not become part of the case file and will be shredded thereafter under Local Rule 270(e). If applicable,
15 the statements should be marked "CONFIDENTIAL." *See* Local Rule 270(d).

16 The statements should not exceed ten (10) pages and should include:

17 (1) a brief recitation of the facts;

18 (2) a discussion of the strengths and weaknesses of the case, including the parties' relevant
19 position on the factual and legal issues and brief review of the evidence to support the parties'
20 factual position;

21 (3) an itemized estimate of the expected costs for further discovery, pretrial, and trial
22 matters, in specific dollar terms;

23 (4) your best estimate of the probability that plaintiff will prevail should this case proceed
24 to trial;

25 (5) your best estimate of the damages or relief plaintiff may recover should this case proceed
26 to trial and plaintiff prevail (in specific dollar terms and/or injunctive relief, if applicable);

27 (6) a history of settlement discussions (including a listing of any current settlement offers
28 from any party, in specific dollar terms), a candid statement of your party's current position on

1 settlement, including **the amount that you will give/accept to settle** (in specific dollar terms), and
2 a statement of your expectations for settlement discussions;

3 (7) a list of the individuals who will be attending the settlement on the party's behalf,
4 including names and, if appropriate, titles.

5 At the outset of the settlement conference, the undersigned may call upon the parties'
6 counsel to give a brief (five-minute) opening presentation outlining the factual and legal highlights
7 of their case before the parties break into separate caucuses. The undersigned reserves the right to
8 dispense with the opening presentations of counsel if the undersigned determines that such
9 presentations are not likely to be productive.

10 Notwithstanding the provisions of Federal Rule of Evidence 408, all statements made by
11 the parties relating to the substance or merits of the case, whether written or oral, made for the first
12 time during the settlement conference will be deemed to be confidential and shall not be admissible
13 in evidence for any reason in the trial of the case, should the case not settle. This provision does
14 not preclude admissibility in other contexts, such as pertaining to a motion for sanctions regarding
15 the settlement conference.

16 Judge Barch-Kuchta will hold a short, pre-settlement conference telephone discussion on
17 **February 24, 2023, at 10:30 a.m.** (dial-in number: 1-888-204-5984; passcode: 4446176). Only
18 the lead attorney from each side² should participate. At Judge Barch-Kuchta's discretion, the joint
19 telephonic discussion may be followed by private telephonic discussions between the judge and
20 each party.
