The February 28, 2020 findings and recommendations (Doc. No. 14) are adopted in full; 2. This action now proceeds only on plaintiff's Eighth Amendment deliberate indifference claims against defendants Williams and Campos; 3. All other claims and defendants are dismissed from this action for failure to state a cognizable claim for relief; and 4.
