A remote settlement conference in this matter is currently scheduled on June 28, 2021, at 11:15 a.m. before Magistrate Judge Stanley A. Boone. In light of the coronavirus (COVID-19) outbreak and the evolving coronavirus protocols, the Court has ordered that the settlement conference occur remotely through the Zoom videoconferencing application. (ECF No. 35.)

The Court, having been informed that the videoconferencing equipment at California State Prison, Corcoran, where Plaintiff is currently incarcerated, is unavailable on June 28, 2021, for

1 good cause continues the settlement conference previously scheduled on that date to **August 13,**  
2 **2021 at 9:30 a.m.** All provisions of the prior order setting the settlement conference, (ECF No.  
3 35), shall apply for the new settlement conference date. The parties, if they have not already done  
4 so, shall submit their confidential settlement statements at least one week in advance of the new  
5 settlement conference date.

6 Accordingly, IT IS HEREBY ORDERED as follows:

- 7 1. The remote settlement conference will be continued to **August 13, 2021 at 9:30 a.m.;**
- 8 2. Counsel for Defendants shall contact Courtroom Deputy, Mamie Hernandez, at (559) 499-  
9 5672 or [mhernandez@caed.uscourts.gov](mailto:mhernandez@caed.uscourts.gov) for the video and dial-in information, including  
10 any necessary passcodes, for all parties. Counsel for Defendants is also required to  
11 arrange for Plaintiff's participation by contacting the Litigation Coordinator at the  
12 institution where Plaintiff is housed and providing the necessary Zoom contact  
13 information;
- 14 3. The writ of habeas corpus ad testificandum directing the production of Ruben Figueroa,  
15 CDCR #T-55771, issued on June 1, 2021, (ECF No. 38), is VACATED;
- 16 4. The Clerk's Office shall serve a courtesy copy of this order by e-mail on the Litigation  
17 Coordinator at California State Prison, Corcoran, and on the Litigation Coordinator of any  
18 other institution(s) which require this information; and
- 19 5. The Court will issue an amended transportation writ for Plaintiff's video appearance in  
20 due course.
