**ORDER EXTENDING TIME FOR**

**INITIAL COMPLAINT**

1 The Court, having considered the Joint Stipulation to allow Mariposa County,  
2 Mariposa County Sherriff's Office, Sheriff Deputy William Atkinson, and Sheriff Deputy  
3 Wesley Smith (collectively, the "County Defendants") additional time to respond to  
4 Plaintiff Jerry Cox's ("Plaintiff") Summon and initial Complaint ("Initial Complaint") in  
5 this lawsuit,

7 **HEREBY ORDERS:**

- 8 1. The County Defendants are hereby excused from filing an answer or other  
9 response to the Initial Complaint until fourteen (14) days after the Court issues  
10 its order ruling on the Receiver's Motion to Dismiss/Motion to Strike the Initial  
11 Complaint.
- 12 2. If the Court grants leave for Plaintiff to file a First Amended Complaint, the  
13 County Defendants are hereby excused from filing an answer or other response  
14 to the Initial Complaint, and the County Defendants will file an answer or other  
15 response to the First Amended Complaint.
- 16 3. If the County Defendants file a motion to dismiss or motion to strike the First  
17 Amended Complaint, the time for the County Defendants to file an answer to  
18 Plaintiff's First Amended Complaint is not due until fourteen (14) days after the  
19 Court's ruling on the County Defendants' motion to dismiss or motion to strike  
20 the First Amended Complaint.
