ORDER GRANTING PLAINTIFF'S
APPLICATION TO PROCEED *IN FORMA
PAUPERIS*

(ECF No. 2)

ORDER DIRECTING PAYMENT OF
INMATE FILING FEE BY WASHOE
COUNTY DETENTION FACILITY

Plaintiff Antoine W. Harris is a former state prisoner proceeding *pro se* in this civil rights action pursuant to 42 U.S.C. § 1983.

Currently before the Court is Plaintiff's application to proceed *in forma pauperis* pursuant to 28 U.S.C. § 1915, filed on October 7, 2019. (ECF No. 2.) Plaintiff's application includes a certified jail trust account statement that reflects the activity in Plaintiff's trust account for the last six months. (*Id.* at 3-5.)

Since Plaintiff has made the showing required by § 1915, the application to proceed *in forma pauperis* will be granted. Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to make monthly payments in the amount of twenty percent (20%) of the preceding month's income credited to Plaintiff's trust account. The Washoe County Detention Facility is required to send to the Clerk of the Court

1 payments from Plaintiff's trust account each time the amount in the account exceeds \$10.00, until
2 the statutory filing fee is paid in full. 28 U.S.C. § 1915(b)(2).

3 Accordingly, IT IS HEREBY ORDERED that:

- 4 1. Plaintiff's application to proceed *in forma pauperis*, (ECF No. 2), is GRANTED;
- 5 2. **The Sheriff of the Washoe County Detention Facility or his/her designee shall**
6 **collect payments from Plaintiff's trust account in an amount equal to twenty**
7 **percent (20%) of the preceding month's income credited to the prisoner's**
8 **trust account and shall forward those payments to the Clerk of the Court**
9 **each time the amount in the account exceeds \$10.00, in accordance with 28**
10 **U.S.C. § 1915(b)(2), until a total of \$350.00 has been collected and forwarded**
11 **to the Clerk of the Court. The payments shall be clearly identified by the**
12 **name and number assigned to this action;**
- 13 3. The Clerk of the Court is directed to serve a copy of this order and a copy of
14 Plaintiff's *in forma pauperis* application on the Sheriff of the Washoe County
15 Detention Facility, via mail, at 911 E. Parr Blvd., Reno, NV 89512; and
- 16 4. The Clerk of the Court is directed to serve a copy of this order on the Financial
17 Department, U.S. District Court, Eastern District of California.
