21 extension of deadlines set in the Court's scheduling order (Dkt. No. 66). Defendants do not object,
22 except to note that the Defendants also have a pending motion to stay all briefing deadlines in this

18 **ORDER**

19 Pursuant to the stipulation of the parties (Doc. 81), and good cause appearing, IT IS
20 HEREBY ORDERED that the Court's scheduling order (Doc. 66) is MODIFIED as follows:

- 22 1. Plaintiffs' motion for summary judgment shall be filed by no later than **January**
23 **19, 2021**.
 - 24 2. Defendants' opposition to Plaintiffs' motion, as well as their cross-motion for
25 summary judgment, shall be filed by no later than **February 9, 2021**.
 - 26 3. Plaintiffs' reply brief in support of their motion, as well as their opposition to

1 Defendants' cross-motion for summary judgment, shall be filed by no later
2 **February 23, 2021.**

3 4. Plaintiffs' motion for summary judgment and Defendants' cross-motion for
4 summary judgment shall be set for hearing no later than **March 24, 2021.**

5 5. The Court holds Settlement Conferences on Tuesdays and Thursdays at 10:30 a.m.
6 Counsel are to thoroughly discuss the advantages of and possibilities for settlement
7 with their respective clients, and each other, in order to propose a date on which a
8 Settlement Conference will be set. By no later than **December 15, 2020**, the parties
9 shall file a joint statement 1) confirming that they have met and conferred, and 2)
10 setting forth three to four proposed Settlement Conference dates in accordance with
11 the Court's calendar.¹
