**JOINT STIPULATION AND ORDER
 TO CONTINUE AMENDED
 COMPLAINT FILING DATE**

1 Plaintiffs WALTER WELLS and SCOTT MCFARLANE (“Plaintiffs”); and defendants
2 COUNTY OF STANISLAUS; CITY OF MODESTO; CITY OF CERES; STANISLAUS

13 4. WHEREAS Jayme L. Walker, the lead attorney for Plaintiffs CARSON; the

15 5. WHEREAS Plaintiffs’ law firm has a conflicting filing deadline pertaining to a
16 writ of mandamus in another action;

17 6. All parties agree that the deadline for filing the Amended Complaint be continued
18 to November 18, 2021;

19 7. Defendants’ responsive pleading shall be filed no later than 30 days after service
20 of the plaintiffs’ Amended Complaint.

ORDER


Pursuant to the stipulation of the parties:
