19	On July 6, 2022, Findings and Recommendations were issued recommending that Plaintiff's	
20	motion to reactivate her prior motion for summary judgment be denied, without prejudice, to refiling a	
21	new and complete motion for summary judgment with supporting statement of undisputed facts	
22	pursuant to Local Rule 260(a). (ECF No. 102.) The Findings and Recommendations were served on	
23	the parties and contained notice that objections were due within fourteen days. (<u>Id.</u>)	
24	On July 11, 2022, Plaintiff filed a rene	wed motion for summary judgment. (ECF No. 105.)
25	On July 26, 2022, Plaintiff filed objections to the Findings and Recommendation. (ECF No.	
26	109.) In her objections, Plaintiff merely states that the Findings and Recommendations have been	
27	rendered moot by the filing of a subsequent motion for summary judgment. (<u>Id.</u>) On this same date,	
28	Plaintiff filed an amended statement of undisp	uted facts. (ECF No. 113.)

2	Subsequent to the July 6, 2022 Findings and Recommendations, this action has been	
3	reassigned to undersigned pursuant to the consent of the parties. (ECF No. 109.) Accordingly, the	
4

6	Based on the foregoing, it is HEREBY ORDERED that:	
7	1. The Findings and Recommendation issued on July 6, 2022 (ECF No. 102) is vacated;	
8	2. Plaintiff's motion to reactive the prior motion for summary judgment (ECF No. 97),	
9	filed on June 15, 2022 is denied, without prejudice; and	
10	3. Plaintiff's renewed motion for summary judgment will be reviewed after it is fully	
11	briefed and deemed submitted.
