22 **STIPULATION**

23 IT IS HEREBY STIPULATED, by and between Plaintiffs and Defendant United States of
24 America that Defendant's response to Plaintiffs' amended complaint is continued from January 22, 2021
25 to **March 23, 2021**.

26 Pursuant to Fed. R. Civ. P. 6(b), good cause exists for a continuation of the response to amended
27 complaint. The United States Department of Agriculture's Food and Nutrition Services ("FNS"), who is
28 responsible for administering the Supplemental Nutrition Assistance Program ("SNAP") under which
this case arises, is currently experiencing a severe backlog in preparing and creating administrative
records for SNAP cases. Consequently, FNS is unable to prepare its administrative record prior to the
response deadline of January 22, 2021. The United States believes that this record is necessary to
adequately respond to Plaintiffs' amended complaint. FNS anticipates that a 60-day extension of time

1 will be sufficient to prepare an administrative record. No previous extensions of time have been sought
2 in this case.
