13	Plaintiff Francisco Javier Vargas, Jr., is a state inmate proceeding pro se and in forma		
14	pauperis in this civil rights action pursuant to 42 U.S.C. § 1983. The matter was referred to a		
15	United States Magistrate Judge pursuant to 28 U.S.C. § 636(b)(1)(B) and Eastern District of		
16	California Local Rule 302.		
17	On February 18, 2021, the magistrate judge entered findings and recommendations,		
18	recommending that Plaintiff's complaint be dismissed without leave to amend as frivolous and		
19	that Plaintiff's motion for temporary restraining order be denied. Doc. No. 16. Plaintiff was		
20	provided an opportunity to file objections to the findings and recommendations within twenty-one		
21	days. Id. Plaintiff timely filed objections on March 1, 2021. Doc. No. 17.		
22	In accordance with the provisions of 28 U.S.C. § 636(b)(1)(C), the Court has conducted a		
23	de novo review of this case. Having carefully reviewed the entire file, including Plaintiff's		
24	objections, the Court concludes that the findings and recommendations are supported by the		
25	record and proper analysis.		
26	Accordingly, IT IS HEREBY ORDERED that:		
27	1. The findings and recommendat	ions (Doc. No. 16) entered February 18, 2021, are	
28	ADOPTED in full;

2	3.	Plaintiff's motion for a temporary restraining order (Doc. No. 7) is DENIED; and
